Allotment to Non-competitive Bidders

3. Government Stock up to 5 % of the notified amount of the sale will be allotted to eligible individuals and institutions as per the enclosed Scheme for Non-competitive Bidding Facility in the Auctions of Government Securities (Annexure).

Place and date of auction

4. The auction will be conducted by Reserve Bank of India, Mumbai Office, Fort, Mumbai-400 001 on January 9, 2006. The application form duly filled in with the bids should be submitted to the aforesaid office on January 9, 2006, by 12.30 pm.

Tenure

5. The Stock will be of ten year tenure commencing from July 2, 2001. The stock will be repaid at par on July 2, 2011.

Date of issue and payment for the stock

6. The result of the auction shall be displayed by the Reserve Bank of India at its Fort, Mumbai office on January 9, 2006. The payment by successful bidders will be on January 10, 2006, i.e., the date of issue. The payment for the Stock will include accrued interest on the nominal value of the Stock allotted in the auction from the last coupon payment date, i.e., January 2, 2006 to January 9, 2006.

<u>Interest</u>

7. Interest at the rate of 9.39 per cent per annum will accrue on the nominal value of the Stock from the date of last coupon payment and will be paid half yearly on July 2 and January 2.
