NOTIFICATION

Auction for Sale (Re-issue) of '7. 40 per cent Government Stock, 2035'

F No.4(2)-W&M/2005 (i) : Government of India hereby notifies sale (reissue) of '7.40 per cent Government Stock, 2035' for an aggregate amount of Rs. 4,000 crore (nominal). The sale will be subject to the terms and conditions spelt out in this notification (called 'Specific Notification') as also the terms and conditions specified in the General Notification F No.4 (9)-W&M/2000, dated 6th May 2002 issued by Government of India as amended from time to time.

Method of Issue

2. The Government Stock will be sold through Reserve Bank of India, Mumbai Office, Fort, Mumbai- 400 001 in the manner as prescribed in paragraph 5.1 of the General Notification F No.4 (9)-W&M/2000, dated 6th May 2002 by a price based auction using multiple price auction method.

Allotment to Non-competitive Bidders

3. Government Stock up to 5 % of the notified amount of the sale will be allotted to eligible individuals and institutions as per the enclosed Scheme for Non-competitive Bidding Facility in the Auctions of Government Securities (Annexure).

Place and date of auction

4. The auction will be conducted by Reserve Bank of India, Mumbai Office, Fort, Mumbai-400001 on January 9, 2006. The application form duly filled in with the bids should be submitted to the aforesaid office on January 9, 2006 by 12.30 pm.

Tenure

5. The Stock will be of thirty year tenure commencing from September 9, 2005. The Stock will be repaid at par on September 9, 2035.

Date of issue and payment for the stock

6. The result of the auction shall be displayed by the Reserve Bank of India at its Fort, Mumbai office on January 9, 2006. The payment by successful bidders will be on January 10, 2006, i.e., the date of issue. The payment for the Stock will include accrued interest on the nominal value of the Stock allotted in the auction from the date of commencement of tenure of the Stock, i.e., September 9, 2005 to January 9, 2006.

Interest

7. Interest at the rate of 7.40 per cent per annum will accrue on the nominal value of the Stock from the date of commencement of tenure of the Stock and will be paid half yearly on March 9 and September 9.
