Place and date of auction

4. The auction will be conducted by Reserve Bank of India, Mumbai Office, Fort, Mumbai-400 001 on May 4, 2006. The application form duly filled in with the bids should be submitted to the aforesaid office on May 4, 2006, by 12.30 P.M.

Tenure

5. The Stock will be of ten-year tenure commencing from April 12, 2006. The Stock will be repaid at par on April 12, 2016.

Date of issue and payment for the stock

- 6. The result of the auction shall be displayed by the Reserve Bank of India at its Fort, Mumbai office on May 4, 2006. The payment by successful bidders will be on May 5, 2006, i.e., the date of re-issue. The payment for the Stock will include accrued interest on the nominal value of the Stock allotted in the auction from the date of commencement of tenure of the Stock, i.e., April 12, 2006 to May 4, 2006.
- 7. Interest at the rate of 7.59 per cent per annum will accrue on the nominal value of the Stock from the date of commencement of the tenure and will be paid half yearly on October 12 and April 12.
