Allotment to Non-competitive Bidders

3. The Government Stock up to 5 % of the notified amount of the sale will be allotted to eligible individuals and institutions as per the enclosed Scheme for Non-competitive Bidding Facility in the Auctions of Government Securities (**Annexure**).

Place and date of auction

4. The auction will be conducted by Reserve Bank of India, Mumbai Office, Fort, Mumbai-400001 on May 25, 2007. The application form duly filled in with the bids should be submitted to the aforesaid office on May 25, 2007, by 12.30 P.M.

When Issued Trading

5. The Stock will be eligible for "When Issued" trading in accordance with the guidelines issued by the Reserve Bank of India in its circular No. RBI /2006-07/178 dated November 16, 2006.

<u>Tenure</u>

6. The Stock will be of thirteen-year tenure commencing from September 3, 2002. The Stock will be repaid at par on September 3, 2015.

Date of issue and payment for the stock

7. The result of the auction shall be displayed by the Reserve Bank of India at its Fort, Mumbai office on May 25, 2007. The payment by successful bidders will be on May 28, 2007, i.e., the date of re-issue. <u>The payment for the Stock will include accrued interest on the</u> <u>nominal value of the Stock allotted in the auction from the last coupon payment date, i.e.,</u> <u>March 3, 2007 to May 27, 2007.</u>

8. Interest at the rate of 7.38 per cent per annum will accrue on the nominal value of the Stock from the date of last coupon payment and will be paid half yearly on September 3 and March 3.
