Method of Issue

2 The Government Stock will be sold through Reserve Bank of India, Mumbai Office, Fort, Mumbai- 400 001 in the manner as prescribed in paragraph 5.1 of the General Notification F No.4 (9)–W&M/2000,dated 6th May 2002 by a price based auction using multiple price auction method.

Allotment to Non-competitive Bidders

3. Government Stock up to 5 % of the notified amount of the sale will be allotted to eligible individuals and institutions as per the enclosed Scheme for Non-competitive Bidding Facility in the Auctions of Government Securities (Annex).

Place and date of auction

4. The auction will be conducted by Reserve Bank of India, Mumbai Office, Fort, Mumbai-400 001 on October 11, 2007. The application form duly filled in with the bids should be submitted to the aforesaid office on October 11, 2007 by 12.30 P.M.

Tenure

5. The Stock will be of ten year tenure commencing from July 28, 2000. The stock will be repaid at par on July 28, 2010.

Date of issue and payment for the stock

6. The result of the auction shall be displayed by the Reserve Bank of India at its Fort, Mumbai office on October 11, 2007 The payment by successful bidders will be on October 12, 2007, i.e., the date of issue. The payment for the Stock will include accrued interest on the nominal value of the Stock allotted in the auction from the last coupon payment date, i.e., July 28, 2007 to October 11, 2007.

Interest

7. Interest at the rate of 11.30 per cent per annum will accrue on the nominal value of the Stock from the date of last coupon payment and will be paid half yearly on January 28 and July 28.
