Implementation of Section 51-A of UAPA, 1967 – Updates of the UNSCR 1267(1999) /1989(2011) Committee's Al-Qaida Sanctions List - Primary (Urban) Co-operative Banks (UCBs)/State and Central Co-operative Banks

Please refer to our <u>circular DCBR.BPD</u> (<u>PCB/RCB</u>) <u>Cir.No.2/14.01.062/2014-15 dated</u> <u>November 28, 2014</u> on the captioned subject releasing the 20th and 21st update of 2014 regarding amendments made in the "Al-Qaida Sanctions List".

2. Ministry of External Affairs (MEA), UNP Division have forwarded the 22nd update dated December 12, 2014 regarding amendment to three entries to the sanction list (<u>copy enclosed</u>). Primary (Urban) Cooperative Banks and State and Central Co-operative Banks are required to update the list of individuals/entities as circulated by Reserve Bank of India and before opening any new account, it should be ensured that the name of the proposed customer does not appear in the list. Further, banks should scan all existing accounts to ensure that no account is held by or linked to any of the entities or individuals included in the list.

October 29, 2009 and ensure meticulous compliance to the Order issued by the

Government.

5. As far as freezing of funds, financial assets or economic resources or related services

held in the form of bank accounts of the designated individuals/entities is concerned, action

should be taken as detailed in paragraph 7 of the circular dated November 16, 2009 in

respect of UCBs and paragraph 4 of the circular dated October 29, 2009 in respect of

StCBs and CCBs.
